CSCC instruct our representative to abstain regarding this proposal.
- "That this General Meeting authorises Council where Council sees appropriate, to poll its membership using solely the means of electronic mail and the list of e-mail addresses of members that it holds, subject to such safeguards as adopted by Council, to obtain the view of its membership on the question or questions put in that poll. EW If the incumbent is not standing that this fact could be passed around the clubs.

FL At the last meeting FL asked if everyone was standing for the same posts in the coming year and KL did not inform the committee that she was thinking of standing down.

KL Reminded the meeting that it is her right to change her mind. The meeting agreed with this.

EW It would have been good if the fact that KL was standing down was known because there might have been people interested in standing. But they wouldn't have wanted to contest the incumbent, particularly as you have been in for one year, and people thought you would have been standing for a little bit longer. It feels a little bit odd that somebody got wind of that and one person has got in a nomination, whilst others have not had the chance to put people forward. Speaking as a member of a club which is not based around Priddy and did not hear what was going on in the Hunters bar.

EW Apologised to KL because this is not personally directed at her.

HB It seems to me that there is a lot of petty politics going on and if people should nominate on the day or a month before they should. In the BEC nominations are either before the meeting or if no one stands, from the floor. But because nominations are known people who disagree can rally around. This causes a lot of political hoo-hah which I can see people are trying to avoid.

HB I found out through the rumor mill yesterday and took it to the BEC meeting yesterday evening, it appears as if that there is a lot of underhand tactics taking place, it would be very nice that if people are standing down, they make it known a month before the meeting such that the clubs can be informed and are then able to consult with their committees.

LW This is part of the remit for the CSCC constitutional committee (Section 4.2) which was formed earlier in the meeting to address these sort of issues.

HB The BEC committees view was, that from an outsider's point of view, it looks like this is very cliquey and petty.
