### 6.1 **Report on caves**

- Rhino The cave is open, rigging guide on website needs updating. AN to copy guide from CCC website.
- **Box Quarries** Gate has been recently damaged and bolts continue to need replacing, funds allocated as required to repair the gate and replace bolts.
- Needs a volunteer to remove the gate for remediation **Compton Martin Ochre Mine** when ground dries out.
- Viaduct Sink Gate is ready to be fitted, we now need some volunteers and dry weather before we drive across field.
- Repair of causeway leading to blockhouse, waiting for drier Swildons weather & no crops, ongoing.

I attended the BCA AGM in the Forest of Dean in July - see draft minutes on the BCA website here <u>http://britishcaving.org.uk/wiki3/lib/exe/fetch.php?media=about:documents:general\_meetings:agm\_minutes\_2015\_draft.pdf</u>.

As directed by the last CSCC meeting, I voted against the first proposal and abstained on the second proposal (although the more contentious wording of the first proposal had been amended by the time a vote was taken). It is currently proposed that next year's BCA AGM will be held on Mendip, in conjunction with the CSCC "DigFest" weekend.

I also attended the BCA council meeting that followed the AGM (minutes don't appear to be on the BCA website yet). The main topic that was discussed was the creation of a "CRoW Liaison" post, which is being filled by Tim Allen.
