#### 12.2 CRoW

The committee does not believe that BCA are putting into place any contingencies to protect the caves if unrestricted access to caves is granted when the CRoW legislation is amended.

**CSCC instruction to JB**; to contact Andrew Hinde with regard to finding out what is the process which should be followed when applying for a section 26 exemption to the act and the expected timescales required before this exemption is applied.

**CSCC instruction to LW**; that he should raise an item for discussion at the next BCA C&A committee.

 In the event of CRoW legislation being amended to allow unrestricted access to caves; what process will be implemented to protect the caves using by bringing into place a restriction using Section 26 of the act.

**CSCC** instruction to JB; to bring to the next BCA committee CSCC committee's views that;

- Tim Allen in his appointment as CRoW liaison officer does not appear to be being impartial
  and is instead is lobbying for change. CSCC committee believes that as Crow liaison officer
  he should be impartial.
- BCA should always follow their constitution.
