10 BCA rep report

Report on BCA council meeting January - Alan Butcher

BCA Constitutional change AGM section 26.2 – Ballot results.

Both houses exceed the 70% support requirement, and so the motion has passed. Only 17% of individual members voted.

P&I committee, since the P&I standing committee was abolished at the last AGM, all P&I decision making is being brought to BCA committee, this took in excess of 45 minutes.

CSCC to raise a recommendation to the next BCA AGM where the P&I committee is reformed as a standing committee so that detailed discussion associated with P&I decisions can be made away from BCA council meetings, thereby speeding up the BCA committee meetings.

Cave Fest, CaveFestUK requested BCA support both financial and otherwise, the CaveFestUK's online presence gets in excess of 10000 hits per month and focuses on the social aspects of caving.

The meeting awarded CaveFestUK a £500 bursary and allows cave fest to use the BCA logo on material.

Adventure Academy, BCA donated £5600 to this commercial organisation whose aim is to supervise up to 14 under 18's caving, at each event. Stories in Stone, a charitable trust appears to be backing this as well.

At the point you decide to form a group which takes under 18's caving, which is not the Scouts or similar you will probably have to go down this route due to safeguarding issues.

Consensus, AB raised at the meeting that he is concerned that there is no attempt to gain consensus between the different BCA regions.

AB There are weakness in the current BCA processes which appear to have not been through properly. We need to proposes changes which will address these weaknesses.

Proposals from AB to the meeting:

1 Now BCA has got rid on the caving clubs vote, BCA needs to add back in caving club's representation. I suggest we double the number of club representatives on council.

2 Need to clarify the BCA manual of operations, regarding the voting to elect unopposed positions. CSCC propose that uncontested applicants are deemed elected.

3 Re-instate the P&I standing committee to streamline BCA council meetings.

4 Where if a member is censured for bullying, the member is not allowed to attend the next council meeting, the intent of this is to stop the member defending their actions and in effect continuing the attack.

AB to draft the detailed proposals.

They will then be presented to the BCA secretary. Deadline for submissions to the BCA AGM 4 April 2020
