8.3 Loxton Cavern

Note by DC, Loxton Caves Access Agreement

There are three significant caves and several minor caves on Loxton Parish Council (LPC) land. These are Loxton Cave, Loxton Quarry Cave and Loxton Cavern. For many years CSCC has controlled access to these caves with the agreement of LPC. Loxton Cavern was rediscovered in 2005. It is particularly notable for its history and the mining artefacts it contains. It was entered by ochre miners in 1757 and described soon after by Dr. Alexander Catcott in his diaries. Loxton Quarry Cave and Loxton Cave are accessed via the standard CSCC key. Loxton Cavern is accessed via a leader system although for most of the time since its discovery it has been closed because the entrance has been unstable. CSCC organised the necessary stabilisation works installing a new entrance pipe and gate. The work is now complete. It has cost CSCC some £2118 to date with further expenses outstanding. This work was organised by the CSCC C&A Officer.

Letter from Graham Price to the CSCC C&A Officer

Sent by email, 08 March 2024 09:59

Dear Wayne,

I noted an email from you when I was away but didn't get a chance to read anything as we have internet problems in Cornwall. When returning home I would normally download everything but for various reasons it didn't happen and now I can't find many emails.

Anyway, here is an update on the Loxton situation

Cerberus has now entered into a formal agreement for access to all the cave and mines on land owned by the Parish Council.

We attended meetings of the PC and provided them with a comprehensive photographic record of Loxton Cavern including a survey and information on the features and historical importance of the site.

Generally, the PC, with the exception of one individual, was not aware of any of the caves; and they certainly were not aware of the importance of Loxton Cavern. The existence of the caves in general was highlighted when persons unknown tried to break into Loxton Cave by digging a hole to the side of the upper entrance, leaving it in a dangerous state being beside a footpath. We rebuilt the entrance, and this raised awareness of the existence of the caves, which in turn led to meetings with the PC. The locking and access arrangements for the caves was explained and this resulted in some concern in that there was no record of any access agreement, or the PC being approached by the CSCC about controlling access. Additionally, they had no record of anyone approaching them about excavations which led to the discovery of Loxton Cavern. I don't doubt that at some point someone representing CSCC talked to someone about access to Loxton Cave and Loxton Quarry Cave but as far as the Parish Council was concerned there were no permissions in place for digging or access.

There was a few month gap when they had meetings and were deciding on a course of action, following which they asked Cerberus to control access under a formal written agreement. Our status as a Registered Charity apparently hasd some influence on this decision. We suggested that access to Loxton Cave and Loxton Quarry Cave might continue under an arrangement with CSCC but they were not happy with this. Consequently, all the caves are included in the agreement, however. even though Cerberus is ultimately

responsible, we would like the CSCC to continue to be responsible for Loxton Cave and Loxton Quarry Cave and access thereto.

Under the agreement the conditions for access to Loxton Cave and Loxton Quarry Cave are as follows:

- 1. All visitors must be members of the British Caving Association or have equivalent liability insurance cover.
- 2. The entrances to the caves must be kept in a safe and secure condition.
- 3. Access to the caves is via the Council of Southern Caving Clubs (CSCC) master key system. Keys are held by all member clubs of the CSCC.
- 4. Visitors may park in the old quarry at the top of Hillview Road. The road is narrow and steep. The number of vehicles should be kept to a minimum. Park neatly and avoid churning up the grass.
- 5. Visitors must act in a responsible and polite manner and the site should be vacated by 10pm at the latest.
- 6. Fires, BBQs or camping is not permitted.
- 7. Excavations to find any undiscovered caves will be subject to approval.
- 8. Visits to the caves that involve any element of commercial gain are not permitted.

A couple of primary requirements by the Council is that all visitors to any of the caves have public liability insurance and there no trips involving commercial gain.

It has also been stressed that failure to keep the entrances in a 'safe and secure condition' will be a breach in the terms of the agreement and may result in loss of access.

The agreement requires access to Loxton Cavern to be via a Warden System along similar lines to that we have been planning to implement. The number of wardens is limited. When we have finalised how the system is to be administered to comply with the conditions of the access agreement, we will update you.

Letter from Rick Gledhill - Chair CSS, to the CSCC Chair and C&A Officer

Sent by email, On 09/05/2024 14:01,

Dear David.

It is unfortunate that due to work and personal commitments there will be no representative from Cerberus at the CSCC AGM.

I have spoken at length with Graham and have read all email communication that is available between himself, the Parish Council and CSCC C&A Officer.

It would seem that there has clearly been a misunderstanding and the phrase 'appropriation' of Loxton access is not correct.

Following a considerable amount of work to re-open the cave, stabilisation and conservation work, the subject of access was raised. It seems that the Parish Council (bar 1 member) were not even aware of the existence of the caves and their historic

importance. Graham attended a Parish Council meeting and gave a presentation on the caves for the interest of those attending.

The Parish Council was not aware that CSCC was controlling access and had no record of there being any agreement.

A formal access agreement was required by the Parish Council as they were concerned with liability/insurance and other matters.

It was explained that this could be set up with CSCC or with CSS (following a question at the meeting) as it was understood by the Parish Council that there was no current formal access agreement in place with anyone. It was made clear to them that this was their decision.

Following a period of consideration and discussion, with which we had no involvement, the Parish Council asked CSS to enter into an agreement. We were not party to this decision but presumably some influencing factors may be historical, the extensive work carried out by CSS, the Society's charitable status, and being more familiar with CSS!

A draft agreement was circulated to the CSS Committee with the background explained and the Committee unanimously agreed to take on this responsibility.

At no stage was there an intent to 'appropriate' access, after all, no-one was aware there was anything in place to appropriate.

If the CSCC can forward to CSS Sec any existing access agreement between CSCC and the Parish Council then CSS would be more than happy to sort any discrepancies between the two agreements and suggest a way forward to a final updated document acceptable to all parties, including control. As mentioned the Parish Council aren't aware of any past agreement.

It is important to note that regardless which body is in control of access, that access will continue to be available and the Parish Council are happy, otherwise this could be detrimental to access in the future.

DC In summary,

The CSS have renegotiated the access to the LPC caves without consulting with CSCC nor informing CSCC that they had entered into direct discussion with LPC. This is despite CSS knowing that CSCC had a prior access agreement and fully expected to reinstate the leader system on Loxton Cavern once the entrance stabilisation work had been completed.

The CSCC has written to LPC who have confirmed that they wish access to be controlled by CSS.

This presents CSCC with some decisions which are set out as proposals below. Given the short time before the next meeting it is unlikely that the Reps. will feel they are in a position to vote on these proposals but they are there to aid and focus the discussion.

1. It is proposed that CSCC accept the CSS offer and administer the access to Loxton Cave and Loxton

Quarry Cave as per the terms of the access agreement with LPC.

2. Should proposal 1 fail it is proposed that CSCC will provide CSS with CSCC's keys and padlocks at cost.

3. It is proposed that the CSCC negotiate with the CSS in order to restore the status-quo, i.e. that the LPC access agreement is restored to the CSCC.

The CSCC Officers have met to discuss the above. Their recommendation is to turn down proposal 1 and accept proposals 2 and 3.

WS I have been in contact with Loxton Parish council informing them that CSCC have a earlier access agreement however the current parish council do not have any memory or retained records of this agreement. They have stated that they are happy with the agreement with the CSS and have no intention of changing this.

WS Graham Price of the Cerberus has informally asked CSCC if they are willing to administer access to Loxton cave, and Loxton quarry cave on behalf of the Cerberus.

Action on all clubs who are members of CSCC that if they are thinking of negotiating an access agreement with a landowner that they involve CSCC at the beginning of the process.

AG Access to the two smaller caves Loxton Cave, Loxton Quarry Cave, was negotiated in 1995 by John Dobson Secretary of CSCC. John Dobson attended at least one of the parish council meeting to agree this so this should be minuted in their records. In addition the gating and entrance stabilisation of these cave was organised by, and paid for by CSCC, both in the 1990s and more recently.

LB From the BEC meeting minutes 2004, Nick Richards and Nick Harding did quite a lot of the original work negotiating access with Loxton Parish Council.

LB The last BEC committee meeting asked if the parish council is acting on behalf of the landowner or is the landowner?

WS Unfortunately the land ownership is not registered on the land registry, which is not unusual. This has only been mandatory since 2004, we assume it is the parish council who own the land.

DC From the discussion the feeling of the meeting is that CSCC would like CSS to realise that they have entered into this agreement in error.

DC The meeting feels that WS should continue talking to the Cerberus Caving Club regarding sorting out these issues. This answers question 3.

LW I would like to bring to your attention that the new BCA treasurer is recommending that subs are increased, BCA subs have not increased since before Covid. This has been well thought out and has been discussed for quite a while.

The main increase is due to insurance issues, there are few suppliers and following an accident at a climbing wall we have had to increase the amount we cover from $\pounds 5$ to $\pounds 10$ million, and premiums have gone up with inflation.

LB My committee has raised the question, Have further future increases been discussed?

LW No, however I cannot guarantee another increase if costs increase again.

LB The BCA insurance is still good value when compared with for example climbing insurance. However few members appear to understand what the insurance covers, its not just landowner indemnification.

LW BCA have not has a publications officer in post, hopefully when we elect a new one at the next AGM this will be one of the first things they publicise.

JD There is a good section of UKCaving where the BCA treasurer has answered a lot of question regarding BCA funding and insurance.
