4 Chair report **Dave Cooke**

DC Report is published on the website

DC **Assistant officers** shadowing the main officers to facilitate continuity in the roles.

6 Treasurer's report **Tom Harrison**

DC BCA treasurer is changing the way regional councils are funded. See Chair's report published on website.

LW We need a constructive discussion with the new BCA treasurer and council, there is a risk of the BCA going bankrupt if we don't change the way we spend money or increase our membership fees.

DC The report is primarily to bring everyone up to speed with what is happening. We are still discussing everything with BCA treasurer and BCA council.

DC In terms of taking this forward this will likely be the remit of TH and the finance committee.

TH Is it reasonable that the maximum that can be claimed without going to the committee has increased from £750 to £3000? In my opinion any project that costs over £1000 should require approval of the committees.

DC I think we should be in favour of lowering this to £1000, Vote for TH and LW take this to the meetings, passed Nem Con.

7 C&A Report Wayne Starsmore

Longleat Estates We are making steady progress with Longleat but there is lot of paperwork to complete.

Bethel Quarry I have spoken to the Landowner, he does now want to engage with us, as is his right.

Hunters Lodge in Sink The gate has been fettled making it much easier to close.

Singing River Mine The access agreement is going week with no complaints.

Wookey Hole This is running well with lots of trips taking place.

Pressure Washers We have spent a lot of time getting these ready, could people get using them.

7.1 Harridge woods

WS There are two proper caves in the area, both Cerberus digs and a number of potential dig sites. We now have an access agreement with them which is along the same lines as we have with charterhouse. They want a permit system similar to the charterhouse system, this is in progress .

DC It is proposed that CSCC adopt the Harridge Woods Nature Reserve License Agreement with Somerset Wildlife Trust.

Vote passed Unanimous

The wording of the permit was not ready for this meeting and it will be proposed to the next meeting.

7.2 Loxton Caves

DC The Cerberus' reply to our letter was circulated last Friday. I feel that this is a reasonable way forward. In 18 months time Loxton parish council will have a review with the Cerberus and if everything is going well the Cerberus will propose handing the management of the caves over to CSCC. The caves will remain with CSCC locks fitted except for Loxton Cavern which will have a lock accessible cave leader system.

DC Currently the cave is controlled by the Cerberus and will be choosing the leaders.

8.1 Proposal for bolting Mangle Hole

WS I was down there last weekend, using the left hand route, the anchors are stainless steel and fairly ideally placed. One was stained with rust but this was part of a Y hang, so backed up. Otherwise they looked good. I had a look at the bolts on the right hand route and these looked to be in good condition. I cannot see any reason to change them. In my opinion replacing them with P bolts is not urgent.

AA I attended a rescue practise in Mangle hole last year and did not notice any issues with the anchors. They are stainless through bolts and it is generally impossible to get these out and re-use the holes, so new anchors will generally have to be in second choice locations. From a cave conservation perspective if the existing bolts look fine it is not worth adding new ones.

AA I will go back to the person who requesting re-bolding of Mangle hole and discuss further the reasoning for the request.
