Actions on CSCC taken from this meeting.

If Natural England change their interpretation of how CRoW act affects caving, the various caving bodies, including CSCC will need move fast to protect various caves on conservation grounds (Section 26).

The various bodies therefore need to formulate plans for this eventuality.

- CSCC therefore needs to generate a list of caves which would be affected by CRoW.
- From this list we need to determine which caves need protection on conservation grounds.

- Clubs who are managing access to these caves need to develop **justifications** as to **why** the access to the caves needs to be controlled.

CSCC Mandate for James Begley CSCC (BCA Rep) to take to BCA council meeting

If DEFRA/Natural England decides that CRoW applies to caving – We will re-consider access arrangements.

If DEFRA/Natural England decides that CRoW does not apply to caving – No change.

Lobbying of DEFRA/Natural England by CSCC

GM Proposed a vote and XXX Seconded a vote:-

Should CSCC directly lobby DEFRA & Natural England to keep their current interpretation of the CRoW act. Namely that CRoW does not apply to caving.

4 clubs voted for, 4 clubs abstained, 0 clubs voted against.

The abstentions were because the club rep's did not feel they had a mandate from their members to make a decision regarding this.

The committee decided that this vote was not carried because it was not part of the agenda for the meeting.
